Letter from the Chief

It is my honor to present to you the Fairmont Police Department's 2017 Annual Report. This is my first full year as Chief of Police and I am very proud of our officers and the outstanding service they provide in our community.

During 2017 our department added several new faces to our staff and found some familiar ones with new responsibilities. In March we added Officer Josh Nelson and Officer Colin Hagert to our staff replacing the two officers who retired in 2016. We then added Officer Jason Christenson in June to fill the additional position created due to the assignment of Officer Mike Beletti to the School Resource Officer position. In April of 2017, then Officer James Tietje was promoted to the vacant sergeant position. We then added two new part time officers, Andrew Kuester and Dayton Asmus to our roster in October of 2017 to help with our overtime costs.



During 2017 our officers responded to 10591 calls for service in our community. This is slightly up 11% from 2016 with a total of 9413 calls for service. Methamphetamines continue to be a concern in our community and a focus of enforcement efforts with our officers. In 2017 we renewed our partnership with the Minnesota River Valley Drug Task Force. In 2017 there were 42 people arrested for crimes categorized in reports to the BCA as "Dangerous Non-Narcotics" which is the category that includes methamphetamines. In 2016 there were 46 people arrested in the same category and 23 in 2015 for comparison. In 2017 our department has continued to focus on improvements in technology as we began the state required process for the implementation of our body camera program in our community. We also began the process to re-establish our K-9 program and we will have the body camera and K-9 program operational in early 2018.

In 2018 we will continue to focus on the quality of service we provide to our community and the commitment we make to those we serve. Our officers are reminded daily that FPD not only stands for Fairmont Police Department but also *Fair*, *Professional*, and *Dedicated* which are the principles that guide our work in the community. We thank the community for its support and allowing us the opportunity to serve the City of Fairmont.

2017 New Officers and Staff Assignments

In 2017 we added one full time officer position to our numbers with addition of the School Resource Officer. This brings our total number of full-time officers to 17 in 2017. In 2015 we were staffed at 15 full-time officers after having been at a staffing high of 19 full-time officers in 2001. We also added two part-time officers to our staff to help assist with the impact of overtime on our patrol schedule. We welcome these new officers on board and forward to them being part of our community.

Full Time Officers

Officer Josh Nelson joined FPD in March of 2017. Officer Nelson is a native of Sherburn, MN and is a graduate of Martin County West and Alexandria Technical College. Officer Nelson joins us after having served with the City of Northfield Police Department, Sherburn/Welcome Police Department, and the Martin County Sheriff's Office. Officer Nelson may look familiar to our community from working as a part time officer for FPD as well as being one of our summer interns when he was in college.



Officer Colin Hagert also joined FPD in March of 2017. Officer Hagert is a native of Cobden, MN and is a graduate of Springfield High School and Alexandria Technical College. Officer Hagert joins us after having served as an officer with the Sleepy Eye Police Department.



Officer Jason Christenson joined FPD in June of 2017. Officer Christenson is a native of Granada, MN and graduate of Martin Luther High School and Alexandria Technical College. Officer Christenson joins us after serving as an officer with the Winnebago Police Department and as a deputy for the Faribault County Sheriff's Office for the last ten years.

Officer Andrew Kuester joined FPD in October of 2017. Officer Kuester is a native of New Ulm, MN and is a graduate of Minnesota Valley Lutheran High School and Alexandria Technical College.

2017 Records Department

In 2017 the Fairmont Police Records Division continues to be staffed by our two hard working Records Technicians, Renae Janssen and Tegan Quade. We are proud to have two employees who are very experienced in all that goes into maintaining our department records and the numerous other duties that they coordinate for our department and our community. Renae Janssen has been serving our community since January of 1989 and Tegan Quade has been serving since October of 2009. Our records division is responsible for numerous things including customer service at the Law Enforcement Center, reviewing and processing data requests, reporting crime stats, maintaining our records system, processing gun permits to purchase, responding to requests from attorneys, maintaining and organizing our evidence room, tracking property and evidence, maintaining record retention schedules, transcription of statements, and administrative support to the chief, lieutenant, and officers. We are very grateful for the high level of organized work they produce for our department and community.

In 2017 our new evidence storage and processing room was completed. We have partnered with the Martin County Sheriff's Office to update some of the evidence processing areas and packaging equipment. This will allow us to institute a bar code based evidence processing and storage system to continue to insure proper evidence storage and retrieval. Also in 2017 our Records Division continued to work with the State of Minnesota Courts in a transition to E-Filing with our state and local courts working towards a paperless system. We also saw the implementation of In-Car Reporting for our officers using the computers in the squad cars for efficient entering of data on incidents. In 2018 we will be focused on working towards the state transition to NIBRS (National Incident Based Records System) that will be replacing the current Uniform Crime Reports for tracking crime statistics.

2017 School Resource Officer


In 2017, the Fairmont Police Department entered into an agreement with Fairmont Area Schools which commenced on July 1, 2017 and continues through June 30, 2020. This partnership re-established our former School Resource Officer position back in our local school district. Officer Michael Beletti was selected for the position and began his duties in late August. Officer Beletti has an office at Fairmont Jr/Sr High School and also regularly visits Fairmont Elementary School.

Roles of the SRO include assisting with promoting and providing a safe learning environment for staff and students, investigation of crimes committed on school grounds, being available to assist with projects and programs, and to establish positive relationships and rapport with the students and staff. The SRO interacts with students on a daily basis and often times visits with classrooms to provide law enforcement related education as a guest speaker to spending time chatting with students at their tables in the lunch room. The SRO has been assigned to investigate Child Protection cases that are screened in by Human Services. In the first four months in the position, Officer Beletti assisted with the investigation of nearly 50 child protection cases.

Officer Beletti is a member of Fairmont Jr/Sr High School's Student Support Team which is comprised of administrative staff. This group focuses on assisting students who are struggling academically and/or are experiencing other issues. Officer Beletti provides insight on issues that students may be having outside of school that administration is unaware of. Officer Beletti represents Fairmont Police Department at the annual Area Career Exploration (ACE) day at Fairmont Jr/Sr High School, Adopt-A-Cop program at Fairmont Elementary School, and Martin County Substance Abuse Prevention Coalition.

We are very pleased to have this partnership renewed in 2017 and we thank the Fairmont Area School District for their support of the SRO program.

2017 Fairmont Police Social Media



In May of 2017 the Fairmont Police Department kicked off its social media platform on Facebook. Officer Craig Fowler was assigned the task of working on the page development and getting the page ready to be published and go live. The Fairmont Police Department then developed and adopted Fairmont Police Policy 10.03 on social media. The Fairmont Police Department has found the new Facebook page to allow our agency to provide updates and information to the community in a convenient and timely manner. Our goal is to keep our community informed on topics, issues, and events in the community and pass along information that reaches our citizens on an effective social media platform. Since the launch of the page in May, the page now has over 1200 followers and continues to grow. We have found that with numerous people sharing our posts, we reach several thousand viewers with each post.

As we enter 2018, we will continue to fine tune this important tool and look for opportunities to keep our community informed and up to date and events and incidents in our area. The page can be found by searching Fairmont Police Department on Facebook. We also have a link to the page on our Fairmont Police website. 2017 CONTROLLED SUBSTANCE INVESTIGATIONS

During 2017 the Fairmont Police Department worked together on multiple narcotics cases and arrested multiple individuals on felony narcotics charges. Officers from our agency were able to work numerous cases using informants, information provided by concerned citizens, and interdiction skills utilized during traffic stops to enforce the drug laws in our community. Our agency has also invested in training opportunities for its officers in specialized areas of narcotics recognition/safety, narcotics traffic interdiction, and narcotics investigations.

Methamphetamine continues to be the focus of drug enforcement efforts in Fairmont in 2017. In 2017 there were a total of 42 individuals in Fairmont arrested for drugs categorized as Dangerous Non-narcotics which is the category that includes methamphetamines. This category is slightly down from the previous year of 2016 that ended with 46 individuals arrested in the same category and 23 individuals from five years ago in 2012. Marijuana charges ended at 12 for the year which is slightly down from 17 in 2016 and remains down from 32 arrests five years ago in 2012.

In 2017 the Fairmont Police Department has worked with multiple departments over the past year to assist in arresting individuals trafficking or manufacturing controlled substances. In the past year our officers have worked with the Martin County Sheriff's Office, Truman Police Department, Sherburn-Welcome Police, and Faribault County Sheriff's Office. In 2017 the Fairmont Police Department has also renewed their partnership with the Minnesota River Valley Drug Task Force. Many of our investigations extend beyond the City of Fairmont and Martin County so we are dedicated to sharing information with outside agencies to assist in the apprehension of drug dealers.

In 2017 the Fairmont Police Department started a new program in partnership with the local first grade students in our community. The focus of Adopt-A-Cop is to build rapport with children in our community by interacting with them early and often. By doing so, we are building relationships with our youth and starting positive conversations at home. School Resource Officer Michael Beletti organized Adopt-A-Cop at Fairmont Elementary School to have all first grade classrooms to "adopt" a Fairmont Police Officer for the school year. With the assistance of administrative staff and teachers, this program began in September. Adopt-A-Cop was given great media coverage by the Fairmont Sentinel, Facebook, and KEYC television in Mankato. Due to initial success, St. John Vianney Catholic School and St. Paul's Lutheran School also adopted an officer into their 1st grade classrooms. Chief Michael Hunter presented a framed certificate to each classroom who adopted one of our officers for the school year.

Officers meet with their classroom monthly to participate in a variety of activities including reading books, assisting with class projects, presenting on safety topics, and enjoying lunch with the students. During the October visit, officers handed out Halloween bags with safety tips and spoke to the children about how to enjoy the night in a safe manner.

Officers who volunteered to help make the 2017-2018 Adopt-A-Cop program a great success include Sergeant Kevin Kelly, Sergeant James Kotewa, Sergeant James Tietje, Officer Shannon Bass, Officer Jaime Bleess, Officer Dustin Schwebke, Officer Michael Beletti, and Officer Colin Hagert. We thank all the schools and staff that have welcomed our officers into their classrooms and look to continue this as a yearly partnership with our schools, staff, and students.

The Citizens On Patrol (COP) program completed its 12th year of service to the City of Fairmont in 2017. The program is currently comprised of six members of local VFW Post 1222. COP members include; Harry Brumbaugh, Steve Langford, Dennis Madsen, Darrel Krahler, Art Elliott, and Robert Meschke. Harry Brumbaugh serves as the internal coordinator for the group and as the liaison to the Fairmont PD. Detective Eric Tonder and Officer Craig Fowler supervise the COP Program for the department.

Each COP member volunteers their time to help the Fairmont PD function more efficiently by assisting with events that require additional manpower. The COP members are provided with a light blue polo shirt, jacket, flashlight, and OC spray. Each COP wears their VFW Post baseball cap in recognition of their honorable service to our country and their membership to the organization. The COPs are given training on OC usage and conflict resolution. Their civilian duties are to observe and report, not to directly engage in any conflict.

In 2017 the COPs continued their efforts assisting the department with numerous activities. Their presence can be seen at traffic and crowd control for parades, street dances, 4th of July fireworks display, Fairmont Triathlon, extended fire calls, severe accidents and whenever needed. The COPs provide foot patrol and security at the Martin County Fair annually to help maintain a safe and fun atmosphere for all fair attendees. COPs organize two person checks throughout the year patrolling our local parks to provide a presence and having positive contacts with the pubic. COPs are on the lookout for criminal activity like vandalism or exhibition driving in the parks and they contact an on duty officer to respond as needed. The COPs also conduct house checks for those residents that ask the Fairmont PD to provide extra patrol of their home when leaving on vacation or when gone for the winter months.

The COPs provide a valuable service to the Fairmont PD and the community. They donate hundreds of hours of their time annually, often during the holidays, and we are very thankful for their dedicated service to the department and the citizens of Fairmont. We hope that area residents will take the time to thank a COP for volunteering their time and for their military service to our country.

2017 Fairmont Police Department Website

The Fairmont Police Department website www.fairmontpolice.org was redesigned in 2017. The website helps to keep our public informed of new crime alerts, people with warrants, sex offender notifications, police department information, body camera info, and helpful public safety tips. It also helps people from out of the area to quickly locate our contact information.

In addition to a fresh looking format, we added the helpful *Resources* page which now offers printable forms online including no trespass forms, application for permit to purchase a firearm, and information regarding landlord/tenant rights and responsibilities.

The Contact Us page continues to be a useful tool for anonymous tipsters to leave information regarding people on our most wanted page, or to report a traffic concern or safety concern in the community. We have received numerous tips regarding narcotics use and other crime tips through the contact us page. The Fairmont Police Department website was especially useful for us in 2017 when we were promoting police officer job opportunities in our department and served as an important recruiting tool. Our website served as the primary location to download and acquire the required documents needed to apply for the police officer positions.

The redesigned website also gives us the capability to simultaneously publish new website information onto Facebook, saving time and streamlining information. When website information is published on Facebook we see increased traffic on our website. In 2017 we utilized the website to share information and receive input from the public regarding the Body Worn Video Program to be implemented within the Fairmont Police Department. Part of this process included utilizing online surveys that users could initiate from the Fairmont Police Department website. Overall, the redesigned Fairmont Police Department Website has proven to be very beneficial tool for the police department and useful resource for the community throughout the year. In 2018 we will continue to use our internet presence to intentionally communicate with the public and promote our police department and community in a positive way.

2017 Police Civil Service Commission



The Fairmont Police Civil Service Commission is comprised of three community members who are responsible for providing civilian assistance and oversight to the Fairmont Police Department with regards to personnel related issues including initial hiring, promotions, and other civil service related activities. The Police Civil Service Commission adheres to the rules and regulations set for the in the Police Civil Service Commission policy book. Police Civil Service Commission members are appointed to a three year term at the approval of the City Council.

During 2017 the Fairmont Police Civil Service Commission was comprised of the same community members that finished out 2016. We are very pleased to have Dan Thiesse, John Korsmo, and Daron Johnson as the members of the Fairmont Police Commission. These commission members volunteer their time to insure that the voice of the community we serve is heard with regards to the operations of the Fairmont Police Department. We thank our current commission and look forward to continuing our positive working relationship in 2018.

2017 Fairmont Police Training







In 2017 the Fairmont Police Department continued to provide a wide variety of professional training for the officers who serve the citizens of Fairmont. In 2017 our Department continued to utilize online training for our officers with our enrollment in PATROL, which stands for Police Accredited Training On Line. This program is developed and sponsored by the League of Minnesota Cities. The use of online technology for training is a major point of savings in our Department's training budget. Officers have the opportunity to complete monthly online trainings classes during their shift that save on the cost of overtime, travel, registration, and other costs associated with traditional onsite training classes. The cost of the online training averages out to be approximately \$5 per POST credit which is very cost effective for our Department. This also allows our officers to complete all yearly OSHA required training while on duty.

The training program is also responsible for the training and supervision of newly hired officers in our Field Training Program. In 2017 our FTO program provides structured training to our three newly hired full-time officers and our two newly hired part-time officers. Our current FTOs are Sergeant Sanow, Sergeant Tietje, Officer Beletti and Officer Fowler. Former FTO, Officer Boltjes assisted with training our part-time officers hired in 2017 due to Officer Beletti's assignment to the School Resource Officer position.

In 2017 all of our officers also completed our two required yearly firearms qualifications, First Aid/CPR training and our required yearly Use of Force training. The Minnesota POST Board requires that all officers complete yearly Use of Force training as part of their peace officer licensing. In 2017 the Use of Force training was conducted by Deputy Markus Murphy of the Martin County Sheriff's Department.

In 2017 we also placed a focus on employee leadership and development. We had several officers attend training opportunities sponsored by the Minnesota Chiefs of Police Association. We had officers attend Officer Leadership Development, Supervisor Leadership Academy, and CLEO and Command Academy. We also had several officers attend training to bolster some new duty assignments such as Department Armor, School Resource Officer, and Narcotics Investigations. The department training program is supervised by Sergeant Chad Sanow.

2017 MCSAP (Martin County Substance Abuse Prevention) Coalition







The Fairmont Police Department has been an active member of the Martin County Substance Abuse Prevention (MCSAP) Coalition since it was founded in 2011 as Fairmont Substance Abuse Prevention (FSAP) Coalition. FSAP was funded through a five-year grant provided by the MN Department of Human Services, Alcohol and Drug Abuse Division. In 2016 a federal Drug-Free Communities grant was awarded to expand efforts throughout Martin County. MCSAP is a group of caring community members, school staff, students, elected officials, media, law enforcement, spiritual and business leaders who work together to prevent underage use and abuse of alcohol, tobacco, and other drugs in Martin County youth. MCSAP primarily works to share resources, ideas, and information to raise community awareness in order to create lasting community change through universal prevention strategies.

In 2017 Chief Michael Hunter started out the year representing our department as part of MCSAP at coalition meetings and at MCSAP events. These duties were then transitioned to our new School Resource Officer Mike Beletti during the summer of 2017. Detective Eric Tonder also partnered together with MCSAP to offer a free Responsible Beverage Server Training to 74 community members in June at the Red Rock Center and officers Michael Beletti, Kevin Kelly and Josh Nelson helped MCSAP and YOCO (Youth Coalition) members with the "Sticker Shock" event at the Fairmont Municipal Liquor Store in April distributing stickers, posters and bottle hangers that remind the community to keep our young people safe by reminding them providing alcohol to a minor is a crime. In 2018 the Coalition will continue to work towards implementing a Social Host Ordinance in various communities in Martin County to provide penalties for those who are providing a place for underage drinking and drug use.

We are very pleased to be a part of this hard working group and the positive impact they are making in the Fairmont and Martin County area.

2017 Fairmont Crisis Intervention Team



Officers of the Fairmont Police Department trained as our Crisis Intervention Team (CIT) have effectively deescalated situations that in the past few years that most likely would have resulted in a physical confrontation. Current members are Sergeant James Kotewa and Officer Bryan Boltjes, Officer Jaime Bleess, and Officer Shannon Bass. The Fairmont CIT officers complete an intense 40 hour training hosted by the Crisis Intervention Team of Minnesota. Officer Shannon Bass, in anticipation for the required Minnesota P.O.S.T (Police Officer Standards and Training) continuing education requirement for mental health went to the coordinator training which has put us well ahead of other agencies. In the recent past our department had participated in a training for officers in crisis intervention techniques sponsored by the Barb Schneider Foundation.

The Fairmont Police Department has seen the benefits of the team and anticipates additional officers will receive the 40 hour certification. In 2018 the department will be sending School Resource Officer Michael Beletti to the training to put the number to five which is almost a third of our department which is well above the current state average for law enforcement agencies. The CIT officers are also used in situations where it may have not been a mental health crisis but when someone was under a large amount of stress such as ambulance calls and during death notifications. Fairmont Police are recognizing a growing percentage of the calls the police department deals with involving a persons in crisis. The CIT also did presentations to local public and private groups and organizations related to the services the CIT officers provide.

One successful example of CIT being used occurred in September 2017. Officers were dispatched to a residence in Fairmont for a report of a suicidal person with a gun. Upon arrival officers observed a male with a 12 gauge shotgun walking to the street wanting to approach and confront officers. Officers later were able to determine by witnesses this person was prepared to die by Suicide by Cop. A CIT officer at the scene was able to get the person to drop the weapon. Upon examination of the gun there was a shell in the chamber and magazine as well as additional shells in his pocket. The person was transported to Mayo Health Systems for a referral to a Mental Health facility. The officer stayed with the highly agitated and intoxicated person and was able to keep the person under control without any use of force even after a few attempts by this person to escape.



A person experiencing a mental health crisis presents some of the most intricate, dangerous, and unstable conditions that a police officer may encounter. Fairmont's Crisis Intervention Team officers have learned techniques to attempt to safely de-escalate and defuse these crisis situations with a focus on citizen and officer safety.



The mission of the Crisis Intervention Team is to help alleviate the problem with safety and compassionately handling a person in a mental health crisis. The training received is based upon the Memphis Crisis Intervention Team (CIT) model, which promotes the use of verbal deescalation skills before using force when confronting a mental health crisis. CIT training has been proven to dramatically decrease the risk of injuries or death to both officers and consumers of mental health services, while also reducing the number of repeat calls. We understand and acknowledge the fact that dealing with a person in crisis in often unpredictable and there is no guarantee that crisis intervention techniques will be effective in every situation without the incident resulting in use of force for the safety of the citizens and the officer. Our goal is to give our officers and community another tool to work towards a peaceful resolution to an incident when dealing with a person in crisis.

2017 Animal Control and Code Enforcement



In 2017 our community saw a slight decrease in animal related calls from 671 from 709 animal related calls in 2016. In 2017 animals at large continue to be the main issue for both (cats and dogs). Followed by barking / nuisance animals. Factors contributing to these numbers include: lost/found animals, dog bites, barking dogs, animals at large, injured animals, and misc. nuisance animals (bats, squirrels, raccoon, and skunks). In 2017 there were six dog bites reported to the police department. In 2017 the Police department had more exotic animal related calls. These animals included an Oklahoma Brown Tarantula, lizard, a California King Snake, and chinchilla. In 2017 a total of 793 animals were surrendered to the Martin County Humane Society.

In 2017 we observed a slight decrease in ordinance related calls from 220 which is down slightly from 2016 (265). Solid waste and junk violations continue to be a primary focus of our ordinance enforcement efforts. Those numbers have been decreasing slightly the past two years and we hope to see this trend to continue. There has been a push to inform the community on the solid waste and junk related issue through education and information with the City Newsletter, Fairmont Police Website, and the City of Fairmont Website that has the ordinances listed online. In 2017 our Code Enforcement Officer worked closely with the newly hired Ordinance Technician at City Hall. This partnership will help us to better address ordinance complaints and expedite the enforcement process. In 2018 we look to focus on continued proactive enforcement of animal and ordinance related offenses.

The Animal Control and Code Enforcement Officer in 2017 continues to be Officer Dustin Schwebke who has served our community in that position since 2007.

2017 Active Shooter/Workplace Violence Training

In 2017 our nation again witnessed several active shooter incidents, including the Las Vegas shooting pictured above. The pictures were taken by Sgt. Tietje as he, along with Chief Hunter and Detective Tonder were visiting Las Vegas when the shooting occurred. The Las Vegas shooting occurred on October 1st, 2017, leaving 58 dead and over 500 injured. As long as these cowardly acts continue, the Fairmont Police Department will continue to provide training to empower our students, classrooms and businesses to be prepared should an active shooter event ever occur.

Chief Michael Hunter helped establish our current workplace violence and active shooter training along with Sgt. James Tietje who is now in charge of setting up and conducting the training. We partnered with Martin County Sheriff's Office Deputy Cory Ballard so we could establish a consistent training program that we could teach throughout the Martin County area. All three of the instructors were on the regional Emergency Response Unit and have received extensive training in various aspects of workplace violence and active shooter response over the years. Chief Hunter is certified as an Active Shooter Response Instructor for law enforcement through Homeland Security and Emergency Management. He is also certified as an ALICE instructor for teaching active shooter response to schools, businesses, and government employees. All three instructors were certified to teach response to active shooter and explosive devices through a grant through Homeland Security and Emergency Management and attended a week long training in New Mexico. Sgt. Tietje and Deputy Ballard are also certified instructors in 3-ECHO response for law enforcement, fire, and ambulance personnel to

respond to incidents of violence in a coordinated effort to provide immediate emergency care for any injured persons. School Resource Officer Mike Beletti is now assisting with the trainings replacing Chief Hunter on the training team.

In 2017 we had the opportunity to provide training to faculty and staff at Fairmont Area Schools, St. Paul's Lutheran School, as well as some local businesses. We are already in the process of lining up further trainings for schools and businesses in 2018. Our goal is to keep this training as a free service to those in the Martin County Area that are interested.





2017 Police Fleet Vehicles



The Fairmont Police Department has several vehicles in the fleet that are utilized by our agency. The current vehicle fleet is comprised primarily of All Wheel Drive (AWD) Ford Explorer Sport Utility Vehicles. Our current squad choice provides extra room as well as all-weather capability that is invaluable during our winter months. Our department has a mix of owned and leased vehicles depending on the assignment. The majority of our marked squad cars are leased through the State of Minnesota which allows for a savings of operational costs with all maintenance and repair costs being paid through the MN Department of Travel Management as part of our lease.

A summary and description of our current fleet is listed below:

In 2017 we added one fully marked primary squad car back into our vehicle fleet which are used by all officers for routine patrol and incident response. These vehicles are fully marked black and white Ford Explorer Police Interceptors they are all on three year leases with Fleet Services. One is a 2015, two are 2016 and two are 2017 model years.

One detective vehicle which is assigned to Det. Tonder. This vehicle is a 2006 Dodge Durango which is owned by the City of Fairmont and will be replaced with a Ford Sport Utility in 2018.

One Animal Code Enforcement Vehicle which is assigned to Officer Schwebke. This vehicle is a fully marked black and white 2013 Ford F-150 truck which is owned by the City of Fairmont.

One K-9 vehicle. This vehicle is a fully marked black and white 2014 Ford Explorer Police Interceptor. This vehicle is on a six year lease with Fleet Services.

One unmarked 2014 Ford Explorer Police Interceptor which is used for training, transports, and as a back-up squad for patrol functions.

One Mobile Command Trailer which can be used at crime scenes, mobilized for major incidents, mobile incident command and is used for public relations at the Martin County Fair every year. This trailer is owned by the City of Fairmont.

2017 Alcohol Sales Education and Enforcement



The sale of alcohol is a legitimate business that plays a valid role in our community. The Fairmont Police Department prides itself on being a professional and pro-active law enforcement agency. Selling alcohol is a privilege that has very specific responsibilities attached to it. Our goal is to keep our community safe of alcohol related injuries and deaths. We work toward that goal through education to help keep our area businesses & servers protected from criminal and civil liability and through alcohol compliance checks of area businesses. We are thankful for having a positive relationship with area businesses that sell alcohol and we strive to work together.

In 2017 the Fairmont Police Department, in partnership with the Martin County Substance Abuse Prevention (MCSAP) Coalition, presented two sessions of "Responsible Beverage Server Training" (RBST) to all employees of businesses licensed to sell alcohol within Martin County with over 70 people in attendance. This course is meant to educate servers on the laws governing the sale of alcohol, how to properly check identification, and how to avoid civil lawsuits. The training is offered on an annual basis and upon request for seasonal employees or special event volunteers within Martin County. RBST is provided free of charge to all attendees and often provides businesses with a discount in their insurance costs for attending. Each attendee receives a certificate of completion after attending the 90 minute presentation.

The Fairmont Police Department conducts alcohol compliance checks of all businesses licensed to sell alcohol within the City of Fairmont. These checks are done during the twelve months following the annual training offered to business employees. Adult buyers, under 21 years of age and under the supervision of a Fairmont Police Officer, attempt to order or buy alcohol at a business. Buyers do not dress up to look older nor do they have any ID on their person during the checks. We want every business to require proper ID to verify that customers are 21 years of age or older and deny the sale of alcohol to the buyer or any person under 21. The purpose of the compliance checks is to enforce liquor sale laws within the City. Our goal with the annual checks is 100% compliance from all businesses by denying sales to all buyers and subsequently all persons under 21 that attempt to purchase alcohol. Compliance checks were conducted in 2017 and only one area business failed by selling to an 18 year old buyer. RBST and Alcohol Compliance Checks are organized & conducted by Detective Eric Tonder.

2017 Treatment Court



In 2017 the FMJC (Faribault, Martin, Jackson, Cottonwood) County Adult and Family Dependency Treatment Courts continued to excel at providing an alternative to incarceration for offenders and a pathway to becoming law abiding & free from substance abuse.

Some restructuring within the program occurred in 2017 with the addition of Cottonwood County to the group and a new Treatment Court Coordinator, Tracy Henning, who coordinates efforts for all four counties. Last year's addition of requiring participants to call in daily for random drug testing in conjunction with continued unannounced home checks of participants by Fairmont Officers at the participants' residences has shown to have a positive impact in accountability for participants. Over 350 in person Treatment Court checks completed in 2017 by Fairmont Officers which is up significantly from roughly 100 checks completed in 2016.

The Fairmont Police Department will continue our partnership with Treatment Court in 2018. Our goals are the support of administrative personnel, active participation by having a Fairmont Police Officer on the Treatment Court Team, random home checks by Officers, and providing support to the participants who are in Treatment Court by doing our part to help them succeed in the program and in their own future. In 2017 Detective Eric Tonder was selected to serve as the FPD representative on the Treatment Court Team and supervises the department's efforts between the Treatment Court and the FPD. We look forward to his continued success in this role and the success of the Treatment Court program.

MRAP Armored Vehicle Acquired through US Government

In 2017, the Fairmont Police Department continued its association with the regional High Risk Entry and Arrest Team (HEAT). The team is a joint powers coalition that consists of approx. 24 tactical officers, two trained negotiators, and two tactical dispatchers. The team provides service to the Minnesota cities of Fairmont, Truman, Sherburn, Welcome, Jackson, St. James, Windom, Mountain Lake, Lakefield, Slayton and Westbrook, along with the Minnesota counties of Martin, Murray, Jackson, Rock, Pipestone, Cottonwood, and Watonwan. The team also provides service to the Iowa cities of Armstrong, Estherville, Spirit Lake, Okoboji, Arnold's Park, Milford, Lake Park, and Spencer, along with the Iowa counties of Dickinson and Clay. The HEAT Team provides coverage to an area of approx. 4600 square miles with a population of approx. 110,000 people. In 2017 the HEAT Team was activated 16 times and responded to situations ranging from drug warrants to shots fired and barricaded subjects. This was an increase from 10 call outs in 2016.

The team members are officers and deputies of the coalition agencies and conduct monthly training sessions as part of their membership. In 2017 the team also conducted a multi-day training at Camp Dodge, in Johnston, IA. The team conducts the multi-day training once a year to utilize the various military training facilities on base in a controlled and structured environment. All members of the team are required to carry their cell phones with them on and off duty which is the method that the team uses to page out members for a request for assistance.

The team uses armored vehicles to keep team members safe during situations where subjects may be armed and threating the lives of officers or civilians. We have used the armored vehicles multiple times to attempt communication with subjects in residences when it is not safe to approach on foot. The team continues to focus on the peaceful resolution of any incident of the safety of the victims, suspects, officers, team members, and all of the citizens of the communities they serve. The team was able to acquire a second armored vehicle in 2017 (pictured above). These armored vehicle are replacing old peacekeeper style armored vehicles that were having many mechanical difficulties.

In 2017 Team members from the Fairmont Police Department included Sergeant James Tietje and Chief Hunter. Sgt. Tietje is currently assigned to a Team Leader role. Chief Hunter had been a member on the team since 1999 holding roles including Team Leader, Crisis Negotiator, Shield Operator, and Entry Team Member. He stepped down in 2017 to focus on his new duties as Chief of Police. In 2018 the Fairmont Police Department will be adding another officer on the team to replace Chief Hunter.

In 2017 the team was also able to acquire a Drone in through Aerial Horizons. The majority of the drone was paid for with Emergency Management grant money from several lowa partner agencies. The drone uses a thermographic camera that sense infrared radiation. This drone can be used to go where it would potentially be unsafe for officers to locate suspects or missing persons. The drone is available to member agencies through the ERU Team.

2017 Body Camera Program



During 2017 the Fairmont Police Department continued to move forward with its body camera program. During the spring of 2017 we began developing the state requirements for our body camera program and policy. We also continued to conduct research on body camera brands and associated data retention issues. In the summer of 2017we selected the WatchGuard Vista Body Camera which will pair with our current squad car cameras. On September 29, 2017 we initiated the required process for public comment on the use of body worn cameras in Fairmont. In October we continued with the process and introduced our Body Worn Camera Policy draft and allowed for public input and public comment. In December of 2017 a final Body Worn Camera Policy was completed and designated Fairmont 3.39. A final purchase quote for eight body cameras and accessories was accepted and the cameras were ordered on January 2, 2018. We anticipate them arriving and being operational in April of 2018. At that time we will conduct a 30 day trial program and evaluate any issues and roll out the cameras for daily use after that.

We greatly appreciate the efforts of the City of Fairmont Mayor, City Council, City Administrator, and the citizens of Fairmont for their support of this program. We believe this will be another tool for our officers to use in documenting quality cases and calls for service in our community. More information about the body camera program and process can be found on our website at www.fairmontpolice.org.

General Statistical Information

The following pages contain general statistical information regarding the categories of calls for service handled by the Fairmont Police Department in 2017. The information also includes similar information for the years 2016 and 2012 for comparison. The information is also broken down to show the number of calls categorized by the day of the week. In 2017, Tuesday accounted for the most calls for service while in 2016, Friday accounted for the most calls for service. Five years prior in 2012, Monday accounted for the most calls for service. The leading categories in calls for service in 2017 are consistent with previous years and continue to be: Traffic Stops, Animal Complaints/Bites, Assist Ambulance, Escorts, Directed Patrols, Information Calls, Civil Calls, Parking Offenses, and Ordinance Violations. Upon review of the calls for service by time of day in 2017, 2100-2200 (9pm to 10pm) is the highest call for service time with 0500-0600 being the lowest calls for service. Uniform Crime Report Information on the breakdown of Part I and Part II crimes are not available until later in the year.

Following the information on calls for service you will find Drug Arrest Information by Category for 2017, 2016, and for comparison the information from five years ago for 2012. The information shows a consistent trend in arrests for the category "Dangerous Non-Narcotics" which is the category that includes methamphetamines from 2016 to 2017. There were 42 arrests in that category in 2017 compared to 46 in 2016 and 23 in 2012. So while slightly down from 2016, it is a 45% increase from five years ago. Arrests for marijuana were down slightly to 12 from the previous year of 17. It should be noted that the 2012 statistics show 32 arrests for marijuana which includes 11 arrests for sales of marijuana that are added into the total number.
